



CABRINI WELLNESS ROUND COMPETITION — TERMS & CONDITIONS

1. Promoter

The promoter is Cabrini Health Limited (ABN 33 370 684 005) of 183 Wattletree Road, Malvern VIC 3144 ("Promoter"), in partnership with the South Metro Junior Football League ("SMJFL").

2. Eligibility

Entry is open to residents of Victoria, Australia. Entrants under 18 years of age must have parent or guardian permission to enter. Employees (and their immediate families) of the Promoter and SMJFL are ineligible to enter.

3. Promotional Period

The competition commences at 5pm Eastern Standard Time ("EST") on 21 July 2026 and concludes at **5pm EST on 3 August 2026**. Entries submitted after this time will not be eligible.

4. How to Enter

To enter, participants must:

- (a) Complete the nine squares on the Cabrini Wellness Round bingo card.

- (c) Ensure their Instagram account is set to public at the time of judging.

Each valid post constitutes one (1) entry. A parent or guardian can submit multiple entries provided each entry is of a different child's bingo card and otherwise meets the above requirements.
