## **& Research Integrity and the Code**

***Mandatory learning for Cabrini Researchers***

All GCP training must meet the minimum criteria for ICH GCP site personnel training identified by *Transcelerate BioPharma* to enable mutual recognition of GCP. Training must comply with the latest updates to the ICH E6(R3) GCP guidelines published 6 January 2025.  
GCP must be renewed every 3 years.







## Introduction

This TransCelerate recognised refresher GCP E6R3 course provides a focused update on the revised International Council for Harmonisation Good Clinical Practice (ICH-GCP) guidelines, equipping clinical research professionals with the knowledge to integrate the E6(R3) requirements into daily practice.

**By the end of this course, you will be able to:**

1. Identify key updates introduced in ICH-GCP E6(R3) and their impact on clinical research practice.
2. Outline updated requirements for informed consent and continuous participant communication.
3. Understand investigator responsibilities for participant medical care and safety oversight.
4. Explain expectations for accurate and traceable source and essential records.
5. Apply data governance and system validation principles to ensure data integrity.
6. Implement risk-based monitoring and reporting practices aligned with E6(R3).
7. Ensure Principal Investigator accountability by demonstrating effective oversight and delegation.
8. Summarise the revised 11 GCP principles and apply them in day-to-day trial operations.

**Expected Time for Completion: 1 hour**




